Sullivan Park & Chapman Park Opening Day

Saturday, May 15, 2021

Due to COVID-19 still being a threat in our community, the Town of Sullivan Parks and Recreation Dept. will be doing the lottery a bit differently this year. Everyone wishing to be included in the lottery is asked to fill out a Pavilion reservation form located in the forms section of the website https://sullivan.recdesk.com. Forms can either be dropped off in the drop box at the main entrance of the Parks & Recreation Dept. building or sent by mail to Town of Sullivan Parks & Recreation Dept. 707 Legion Drive Chittenango, NY 13037.

To be included in the lottery, forms must be in hand by Friday, February 26, 2021. The office staff at the Parks & Rec. Dept. will then do a random drawing and input these reservations in the system before opening up online reservations on March 1st. We ask that an alternate pavilion and date be listed in case your first choice is already taken.

For residents preferring to make reservations on our website, online reservations will be accepted starting Monday, March 1st, 2021 at 5:00 p.m. for residents only and Tuesday, March 2, 2021 at noon for all non-residents. All online reservations can be made on the website at https://sullivan.recdesk.com. Resident reservations are free and the cost for Non-Residents is \$150.00.

Note: Pavilion Lottery is open to Town Of Sullivan Residents only!
